- Provider Quality Incentive Register with Stellar Health at www.stellar.health today and earn financial incentives for what you already do today providing outstanding care!
- Don't forget to update your provider data if it has changed, and please send all recredentialing documents timely upon request.
- Don't forget the importance of complete coding and documentation in member records. If it's not on the claim or in the member chart, it didn't happen! Chronic conditions must be coded annually. The acronym MEAT is a helpful guide: Monitoring, Evaluation, Assessment, and Treatment.

## **Focus on Diabetes Management**

Glucose monitoring has a significant role in managing the effectiveness and safety of treatment in patients with diabetes. The American Diabetes Association (ADA) "Standards of Care in Diabetes—2023" recommends that an A1c test be performed at least twice a year and that the A1c goal for nonpregnant adults should be <7%. Encourage patients to build positive health behaviors such as adopting healthy nutrition and good physical



activity habits, smoking cessation, adhering to medication regimen, and other self-management activities. Together we can help patients achieve diabetes treatment goals and maximize their quality of life.
